**Enclosed** is the application form for a Musicians Institute Opportunity Scholarship for the 2009/2010 academic year. The MI Opportunity Scholarship is designed for middle-income students who require financial assistance in order to attend any of Musicians Institute's Certificate, Associate of Arts, or Bachelor Degree programs. A maximum of \$1,000 per quarter will be awarded to qualified recipients, not to exceed \$6,000 total. Scholarships are for tuition credit only and recipients must maintain a minimum 3.0 GPA per quarter to remain eligible. Criteria for the Scholarship are listed on the enclosed application. Scholarships are awarded on a first-come, first-served basis up to the maximum number available.

#### **How do I apply for a MI Opportunity Scholarship?**

- Complete the enclosed Scholarship Application form.
- Complete the enclosed GPA Verification form and submit it to your High School for processing.
- Return the Scholarship Application, completed GPA Verification form and 2008 TAX RETURNS to the Financial Aid office at the address listed above. Incomplete applications will not be considered for the scholarship.

#### **What happens after you apply for the Scholarship?**

- The Financial Aid office will check your scholarship application for errors. If the application is complete and accurate it will be considered on a first-come, first-served basis.
- After your award status is determined, you will be notified by mail.
