

# INTERNATIONAL STUDENT INFORMATION - Application, Payment, and Visa Process

Once you have been accepted to MI and have received the acceptance package there are 4 further steps that you must take before you can attend classes (steps 1 & 2 should be completed and sent to MI at the same time).

- 1. Make an advance partial tuition payment.
- 2. Submit a Confidential Statement of Finances form and supporting documentation (official bank balance statement).
- 3. Obtain the I-20 form (for your student visa).
- 4. Obtain your student visa from the US embassy or consulate in your country.

Complete details for each step as follows. Please read this complete document carefully.

## 1. MAKE AN ADVANCE PARTIAL TUITION PAYMENT (See Page 2)

Tuition Payment for one quarter (3 months) must be paid in advance by Bank Wire Transfer or Credit Card. In the case of Bank Wire Transfer please make sure that your bank includes the student's full name so that we can correctly credit your account. DO NOT SEND CASH.

(Visa, MasterCard, Discover & American Express cards only)

### 2. SUBMIT A 'CONFIDENTIAL STATEMENT OF FINANCES' FORM

Email to MI a completed Confidential Statement of Finances form and a balance statement or signed official letter from your bank to prove that you have enough money for tuition and living costs while attending MI. You must be able to show sufficient finances to cover living expenses (at \$12,000 per year) plus the balance of the tuition for either the duration of the program or one year, whichever is shorter. All foreign documents must include an official English translation.

### 3. OBTAIN YOUR I-20 FORM FROM MUSICIANS INSTITUTE

When we receive your tuition payment, Confidential Statement of Finances form, and Bank Statement we will send you the I-20 form. Because of the important and time-sensitive nature of these documents, MI reserves the right to use UPS courier services to send the I-20 form, and the student shall be responsible for the cost of this service at the time of registration.

### 4. OBTAIN YOUR STUDENT VISA

Important! You must take the I-20 to the U.S. Embassy or Consulate to get your Student Visa. Do not come to MI with a tourist visa (except for MI Select). You must have the correct visa or you may be denied entry into the United States. It may take up to 4 or 5 weeks to get a student visa at the American Embassy or Consulate, so please start the process as soon as possible.

- Canadian Students: You do not have to go to the American Consulate. You only need to show the I-20 form, passport and SEVIS fee receipt at the port of entry into the United States.
- Swedish Students: If you are receiving CSN financial aid you do not have to send the advance tuition payment, as in paragraph 1 above. You must simply email a copy of your CSN 'final' approval letter, a completed and signed Statement of Finances form, and a bank balance statement showing the balance not covered by CSN financial aid to MI's International Student Office, email international@mi.edu. Upon its receipt we will send you the I-20 form for your student visa by UPS or Federal Express Courier
- For more details on how to complete any of these steps, please contact your Admissions Advisor or the International Student Office at Musicians Institute.

<sup>\*</sup>Tuition will be refunded if you cancel for any reason and do not attend classes.

<sup>\*</sup>Please note that you will be responsible for all bank fees, including those charged by our bank to receive the transfer. If these fees are not included in your initial wire transfer, you will be responsible for their payment during registration.

# INTERNATIONAL STUDENT INFORMATION - Finances, Visas, and Health Insurance

### **AFTER YOU ARRIVE - TUITION AND MONEY**

You will need some money upon arrival in L.A. to pay rent, tuition, fees, etc. Try to avoid carrying large amounts of cash. **Tuition must be paid before you can start classes**. The best way to pay tuition is with a bank transfer, however you may pay with Visa, MasterCard, Discover card, cashier's check or a personal check. Even if you have financial aid from your country, any tuition balance not covered must be paid on your Registration day.

### **OPENING A BANK ACCOUNT**

When you arrive at MI, the International Student Office will help you open a US bank account. It will take 2 weeks for your check to clear once you have opened an account. You can easily cash checks and open a bank account with a foreign passport, U.S. ID card or driver's license. We can assist you in this process.

### APPLYING FOR A CALIFORNIA IDENTIFICATION CARD (ID) OR DRIVER'S LICENSE (DL)

If you wish to apply for either of these you will have to go to the California Department of Motor Vehicles (DMV). Before you apply for an ID or DL, we must first register your I-20 in SEVIS. This process can take up to 2-weeks. The DMV is located at 803 N. Cole Ave., Hollywood, CA 90028, and can be reached by calling (800) 777-0133. The International Student Affairs Office can assist you and provide you with directions to the DMV.

#### **WORKING IN THE U.S.**

F-1 visa students may not work off campus during the first year of studies. After that you may qualify for OPT (Optional Practical Training). Please inquire about OPT at the International Student Affairs Office after you arrive at school. **There are not many jobs available on campus** so please be sure you have enough money set aside to cover your living expenses during your study period.

### **TOURIST VISAS**

PLEASE DO NOT get a Tourist Visa if you plan to attend classes at Musicians Institute. The U.S. Immigration Office in Los Angeles may not allow you to change it to a Student Visa in time to start school. You must have a F-1 Student Visa in order to attend Musicians Institute. PLEASE DO NOT come to MI without a visa from the U.S. Consulate in your country. If you come to the U.S. with a "visa waiver" (3-month visitor pass) you will not be allowed to change it or extend your stay and you MUST return to your country upon its expiration.

### **AFTER GRADUATION**

If your "Authorization to Stay" date is going to expire before your graduation date, please see the International Student Advisor to help you arrange for an extension. You MUST file the extension at least 45 days prior to the expiration date of your authorized stay. Please be aware of the expiration date on your I-20 FORM and DO NOT LET IT EXPIRE.

## **HEALTH INSURANCE REQUIREMENTS**

All international students are encouraged to purchase a health insurance plan being offered through MI. We offer an excellent plan from Ascension Collegiate Solutions at around \$150 per month. All international students should enroll using the online enrollment portal for Musicians Institute at <a href="www.4studenthealth.com">www.4studenthealth.com</a>. This web site is administered by our insurance program administrator, Ascension Collegiate Solutions. This health insurance is mandatory.
